Passholder benefits and/or rates may not be combined with any other offer, discount, promotion, or special. Passes and it's benefits are non-transferrable and are not valid with some group play, leagues and/or tournaments. Towhee Club is a public facility, therefore passholder tee times are subject to availability, and certain time frames and/or days may be unavailable to passholder play due to tournaments, groups, or events.

Towhee Club reserves the right to revoke, revise, or modify passholder programs at anytime without prior notice. Passholder benefits are only applicable to the member(s), not guests. Some limitations and exclusions may apply to merchandise discounts (Ex. Golf balls) and Birdsong Social discounts. Passholders must abide by all golf course policies and rules-refusal to do so may result in revocation of your pass without refund. Passholder benefits begin on the date of purchase, and expire one (1) year from date of purchase. This membership requires a one (1) year commitment. If purchasing in two installments, you must pay 65% of the total membership in your first installment, followed by the remaining 35% after the initial 6 months. After 6 months if you refuse to pay the remaining installment, you will not receive a refund and your membership will be immediately terminated. Taxes are not included in the price.

*Family Passholder option includes a spouse/partner, or children 22 years or younger living in the same household and/or that are full-time students. Family members MUST provide proof they reside at the same address as the main member and students must provide proof of student status and date of birth.
